Where identifiable data is required for research, patient consent will be needed, unless there is a legitimate reason under law to do so or there is support under the Health Service (Control of Patient Information Regulations) 2002 ('section 251 support') applying via the Confidentiality Advisory Group in England and Wales.

Sharing of aggregated non-identifiable data is permitted.

We may share information with the following medical research organisations with your explicit consent or when the law allows: This privacy notice will be updated whenever we participate in new research programmes. You have the right to object to your identifiable information being used or shared for medical research purposes. Please speak to the practice if you wish to object.

Article 6(1)(a) "the data subject has given consent to the processing of his or her personal data for one or more specific purposes". or Article 6(1)(e) may apply "necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller." And in addition, there are three possible Article 9 justifications.
